### Terms & Conditions:

#### Registration of Peanut Processing Unit;

- Shall safeguard to prevent infestation / re-infestation during all steps of the export chain;
- Shall issue a Certificate for each consignment stating that the Peanut has been processed in their unit for export with their registration number allotted by Directorate of Plant Protection, Quarantine and Storage, quantity and nature of packaging of Peanuts.
- The validity of Certificate is subject to monitoring / auditing of the facility by the joint inspection team for continued compliance of SOP at two-years interval as per the terms of Para 9 of SOP.
- Shall ensure that peanuts consignment is free from pests including Khapra beetle (*Trogoderma granarium*) and Peanut bruchid (*Caryedon serratus*), failing which (interception of any pest in such commodity in importing country), registration of Peanuts Processing Unit shall be suspended with immediate effect and reinstatement audit shall be done after three months by the joint inspection team.
- The certified unit shall abide by the instructions and guidelines issued by the Plant Protection Adviser from time to time. For renewal of validity for continuation the applicant must apply 45 days in advance, failing which annual audit fee will be applicable as fee for registration.
